

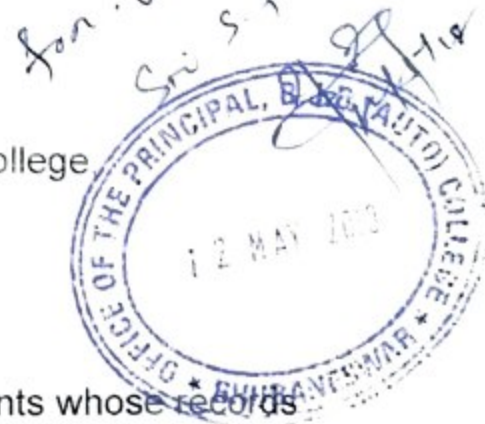

Sir,

Inviting a reference to the aforementioned subject, I am directed to say, that from the online database of State Scholarship Portal it is found that less percentage of online applications pertaining to e-Medhabruti Scholarship, Vyasakabi Fakir Mohan Bhasabruti and Gopabandhu Sikya Sahayata Yojana have been validated till date which is accounted as very poor. The last date of validation has been extended upto **31.08.2021** for completion of online validation. **No further extension shall be made.**

It has come to the notice of Department that the colleges authorities are insisting upon submission of physical copy of online application along with other documents at the time of online validation due to provision at para (x) of instruction manual of the e-Medhabruti guideline and not validating the online applications due to non-submission of same. After introduction of State Scholarship Portal from this year 2020-21, all the relevant documents are uploaded in the online application and there is no necessity of submission of physical form of application at college level.

I would therefore request you to take immediate necessary steps to expedite the validation process basing on the online documents and the data available with the college and complete the process of validation within the stipulated period.

Sub: Regarding online validation of applications for award of e-Medhabruti (Fresh) and (Renewal) for the year 2018-19 in respect of SAMS colleges (Jr. Merit/Sr. Merit)

Madam / Sir,

I am to say that SAMS data of eligible students (60% and above marks) have been pushed into concerned Administrator log in / Principal's log in for award of fresh and renewal scholarship under e-medhabruti scholarship scheme of the Higher Education department.

Hence in order to expedite disposal of e-medhabruti scholarships to eligible students, the following procedure is to be followed henceforth.

1. **For the Fresh cases**, the required documents such as income certificate, mark sheet, resident certificate and bank account details have to be collected from concerned students and verified as per e-medhabruti guidelines (10th / +2 marks should be more than 60% for +2 / +3 scholarship, should be a resident of Odisha and combined parental income should not exceed 6 lakhs p.a) and **if found correct they have to be scanned and uploaded** in the existing college Administrator log-in under the tab 'scholarship details'.

2. The Principal has to ensure that the correct data has been uploaded.
- Genuineness of the student i.e. he/she is studying in the college/institution for the particular year.
 - Correct data regarding residence, parental income, mark secured and bank details have been entered.
 - Only students who are residents of Odisha are eligible for scholarship.
 - If any error is found, the Principal will instruct the administrator to rectify the error. If all data are correct, the Principal will validate the record for consideration by the department. **Merit list will be drawn only from the records validated within the timeline given.**
3. If any student had applied more than one time, only single record will be validated by the Principal.
4. Only aggregate marks secured (as per 10th / +2 board examination marksheet) out of the maximum marks prescribed shall be validated.
5. If any ineligible student record is shown in the list, such record shall be rejected by the Principal with reasons for ineligibility.

RENEWAL


For Renewal of 2018-19, eligible students present in previous selection list are listed in the Principal's login id as per their eligibility on account of duration of course and only students continuing in the concerned academic year has to be validated by the Principal. **The Principal / Head of Institution will be personally responsible for validating only genuine students from the records displayed in their login.**

The Principals are requested to publish notice in their respective colleges in this regard for general awareness of students.



This assistance can be given on and above any other scholarship. Previously applications for such financial assistance were invited through offline mode. 


Therefore, you are requested to submit the actual requirement by 20.10.19 positively and take proper steps to cover all eligible PwDs students of your jurisdiction.

This should be treated as very important.


