

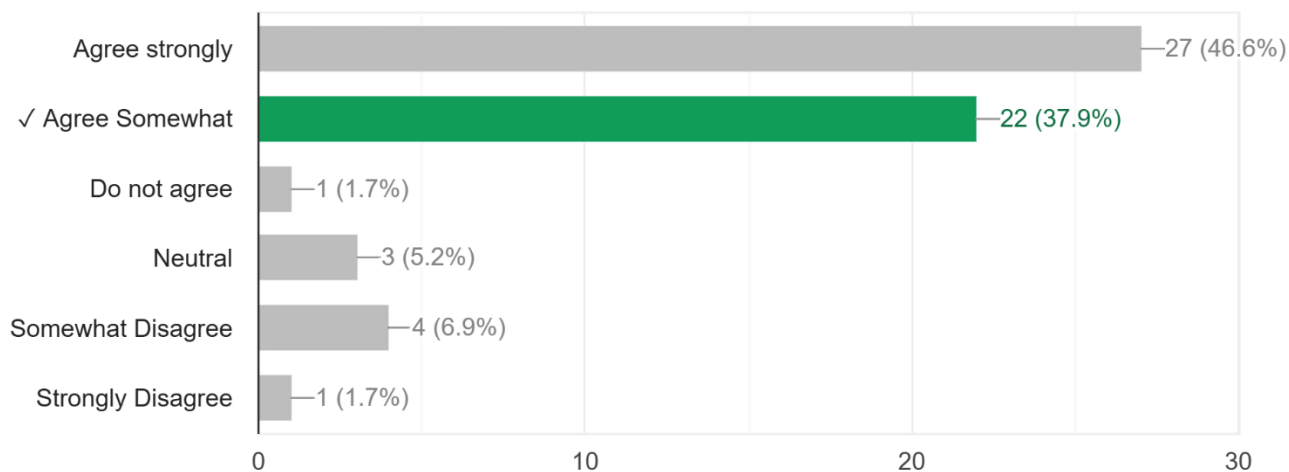

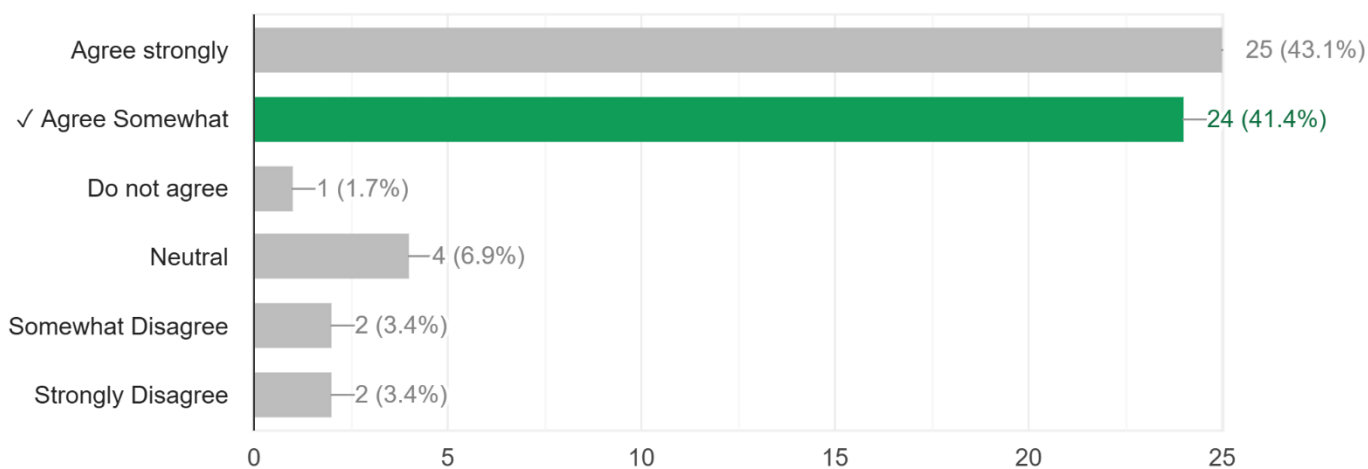
1. The content and scope of the courses are clear and well-defined.

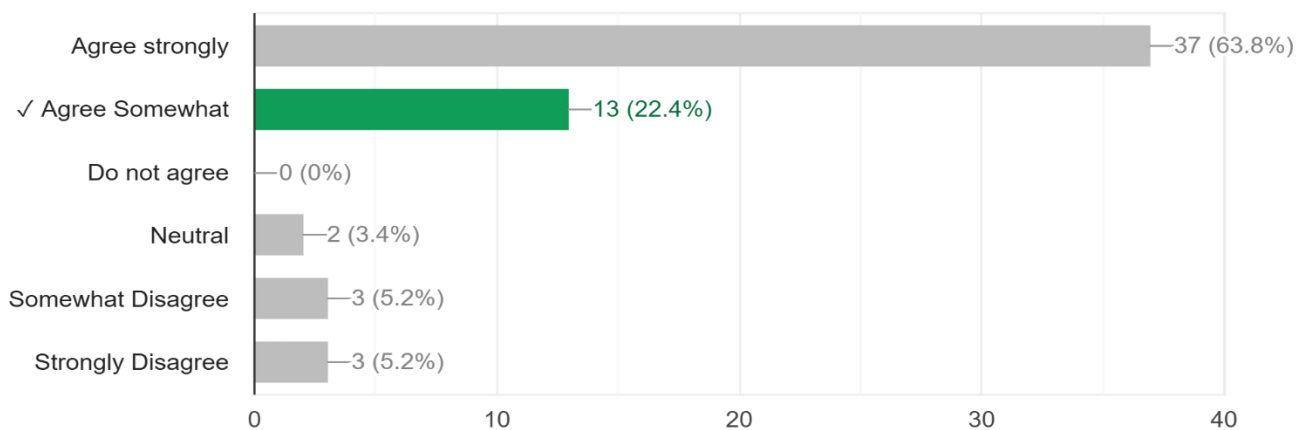
2. Syllabus is contemporary and need-based.

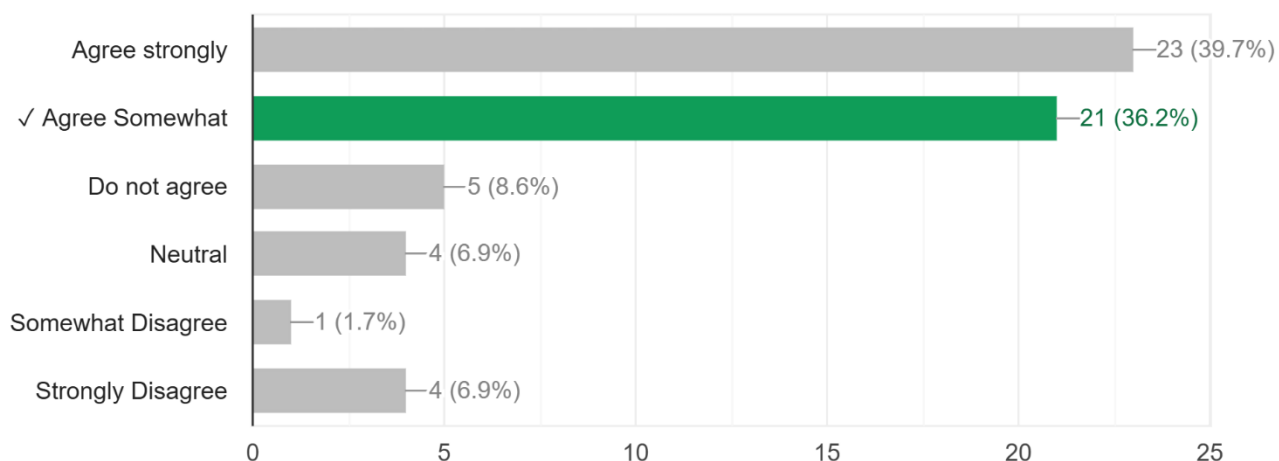
3. The depth of the course content is adequate to have significant learning outcomes.

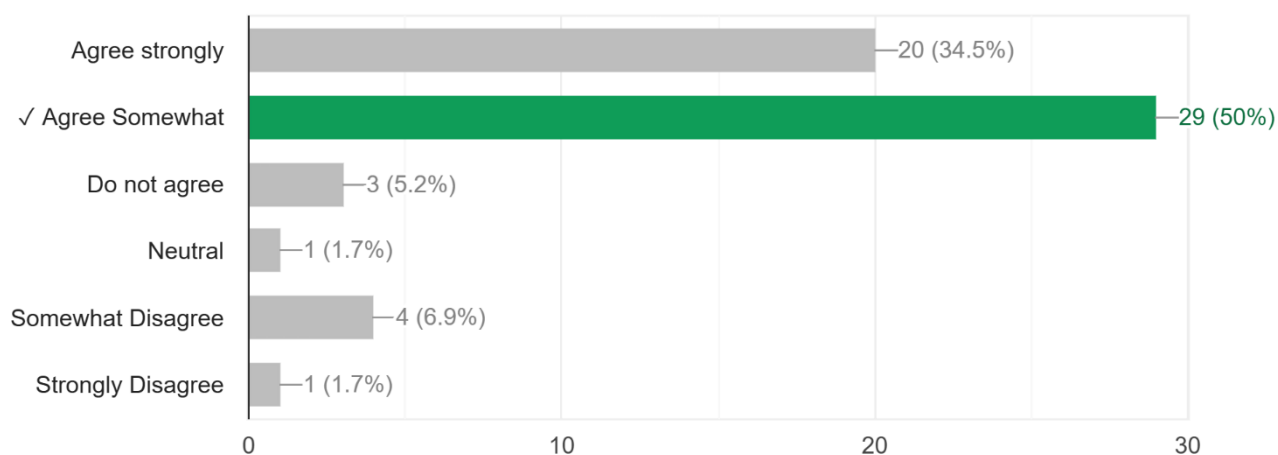

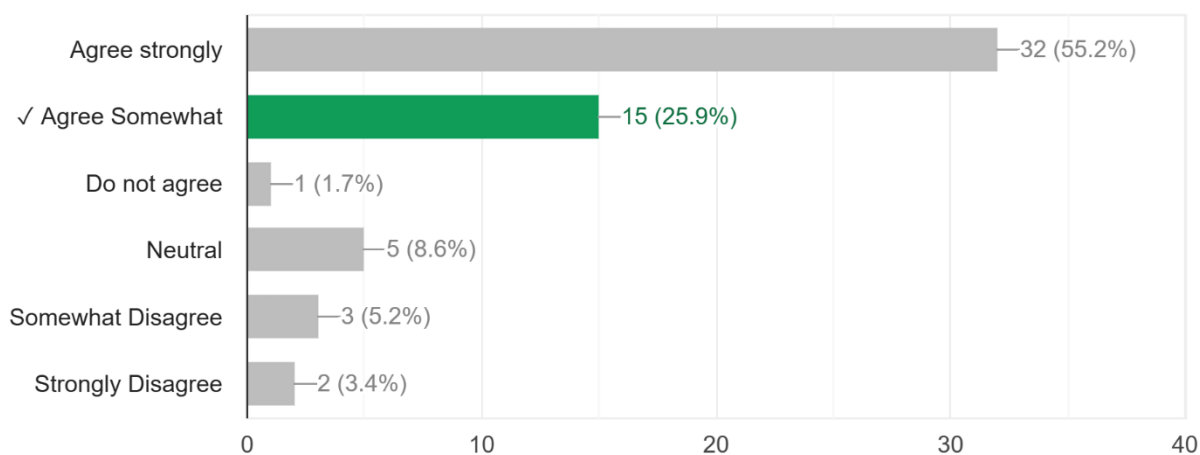

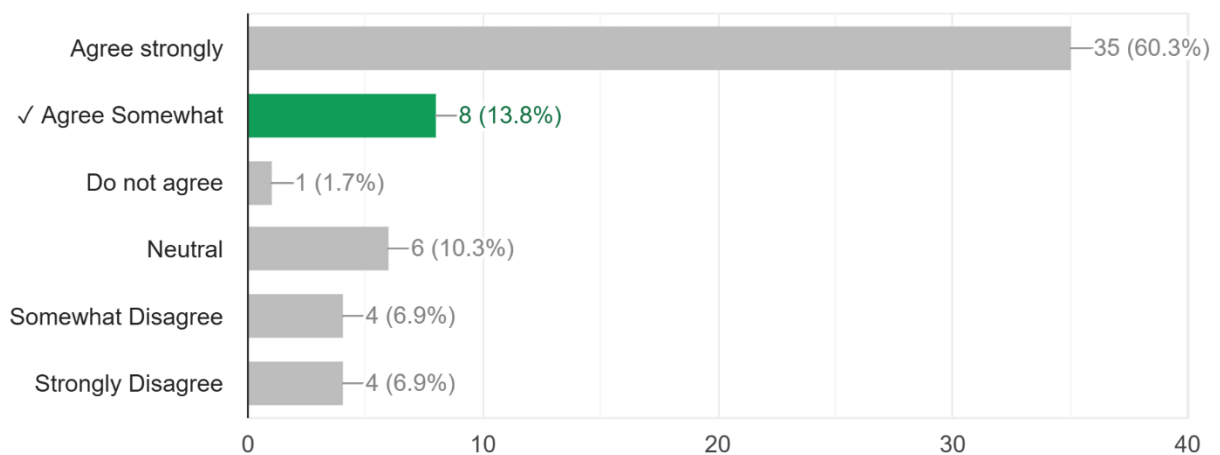

Again it is quite evident that answering 100 marks questions with contemporary Odisha CHSE style is creating problem for students to answer within 3 hours. Question pattern requires modification so that the length of answers may be decreased, and students get adequate time to answer as well as revise questions. One more suggestion it would be good if

students get 10 minutes more to read the questions before answering as is provided in CBSE board.
